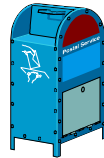

HELPFUL HINTS

Because DMV issues registrations on a biennial basis, fee calculation can be confusing.

- For the initial plate purchase, customers will receive credit for any previously paid registration fees.
- If fees were paid this year, customers receive credit for the full two year (biennial) registration. For example, the fee for an automobile that was registered this year would be \$30.00.
 $\$54.00 - \$24.00 = \$30.00$
- If fees were not due this year, customers receive credit for one year. For example, the fee for an automobile with one year remaining on the biennial registration would be \$42.00.
 $\$54.00 - \$12.00 = \$42.00$
- If fees are due at renewal, the total fee of \$54.00 will be required.

APPLY FOR A SPECIAL NON-PROFIT ORGANIZATION PLATE

COMMONLY ASKED QUESTIONS...

Who approves the special plate?

The Department of Motor Vehicles must approve your organization's plate design. By law, they must ensure that no plate design is offensive or falls below department standards.

How is it done?

To request a special organization plate, an authorized representative of your organization must submit an application and provide the following to the department:

- A copy of the organization's 501C (3) certificate
- 400 prepaid applications or a deposit check of \$4,000.00 to the Department of Motor Vehicles
- Camera-ready artwork for the potential design of the plate
- Written authorization for the use of any copyrighted or registered logo, trademark or design, and
- A marketing plan for the sale of the special license plates which must be approved by the Department of Motor Vehicles

Once your organization receives approval for the special plate, you may submit this membership application to the department.

Note to the Organization:

Organization applications must be submitted separately for the organization as a whole. Only an authorized representative of the organization can submit the information. Use this application to submit 400 or more member applications with the special plate request. This application can be photocopied.

Member Application:

Members must present a current organizational membership card or a letter on organizational letterhead that states that the applicant is a current member.
