### FEE SCHEDULE

Fees are based on the GVW of your vehicle. The GVW is determined by the empty weight of your vehicle plus any additional weight the vehicle will carry (gasoline, supplies, etc). For up to 4,000 lbs, the biennial registration fee is \$10.00 For each additional 1,000 lbs. of weight or fraction over 4,000 lbs., \$8.00 is added.

Up to 4,000 lbs.	\$10.00
4,001-5,000 lbs	\$18.00
5,001-6,000 lbs	\$26.00
6,001-7,000 lbs.	\$34.00
ETC...	

\*\* There is no maximum gross vehicle weight. For example, if someone declares a vehicle at 200,000 lbs., the registration fee will be calculated using the formula. No matter what the registered amount, **any vehicle weighing more than 80,000 lbs. must have an oversize/overweight permit from SCDOT** before operating on the roads.

### YOUR APPLICATION MUST INCLUDE:

1. If the vehicle is not currently titled by owner in SC, then additional supporting information is also required: a title, a completed application for title ([Form 400](#)), a bill of sale, and the \$15.00 titling fee plus the applicable infrastructure maintenance fee.
2. A current property tax receipt for the vehicle being registered. The receipt must be stamped "Paid" by your resident county treasurer's office.
3. License fee for the desired weight or \$10.00 transfer fee, whichever is applicable.
4. For vehicles with a GVW of greater than 55,000 lbs, a [HVUT Exemption Form \(MC-2290\)](#) is required to document the vehicle's exemption from paying the Heavy Vehicle Use Tax.
