**Section 56-3-670** provides that: any person who shall certify to the department that he is a bona fide farmer and who is issued a farm license plate for the purposes as defined herein and who uses such license plate for purposes other than those defined shall be guilty of a misdemeanor and, upon conviction, shall be punished by a fine of not more than two hundred dollars or imprisoned for not more than thirty days, or both.

### YOUR APPLICATION MUST INCLUDE:

1. A copy of your current registration or completed application for title and registration. If the vehicle has not been registered in S.C., a \$15.00 title fee will be due, plus any applicable IMF and/or late registration fee which may be due.
2. A current personal property tax receipt for the vehicle being registered unless a current license is being transferred. The receipt must be stamped "Paid" by your resident county treasurer's office.
3. License fee for the desired weight or \$10.00 transfer fee, whichever is applicable.
