

30-Day Temporary Plates are issued pursuant to SC Code §§56-3-2600 and 56-3-2900.

TO APPLY:

- 1. All customers are required to complete section A.
- 2. Only dealers or manufacturers are required to complete section B.
- 3. Only individuals are required to complete section C.
- 4. Include payment for the desired number of 30-Day Temporary Plates, which cost \$20 per plate.

Note: Please see the conditions below.

CONDITIONS:

*Only dealers may purchase temporary plates in bulk, up to 25 plates per day.

Individual purchasers may only buy one temporary plate per vehicle.

The South Carolina Department of Motor Vehicles, upon request, shall provide temporary license plates and registrations designed by the Department to nonresidents of South Carolina, licensed motor vehicle dealers, and to manufacturers in South Carolina who produce trailers or semi-trailers that apply for such plates and cards.

Temporary license plate shall be on the vehicle for which issued and shall not be transferred, loaned, or assigned to any other person or vehicle.

Temporary license plate and registration shall be valid for thirty days from the date of issuance.

Liability insurance coverage must be in force for at least the minimum amounts required by South Carolina law.

The registration should be carried in the vehicle described while in operation.

Date of issue, make, identification number, and expiration date on actual temporary plate must be written in permanent black ink or black ink covered with transparent tape.

Motor Vehicle Dealers and Motor Vehicle Manufacturers of New and Unused Vehicles

Dealers and Manufacturers, subject to the limitations and conditions hereafter set forth, may only issue temporary license plates to owners of vehicles which are to be permanently licensed in a state other than South Carolina.

Manufacturers of Trailers or Semi-Trailers in South Carolina Only

Manufacturers may issue temporary plates to a trailer or semi-trailer that is being moved from the manufacturer to the dealer's or purchaser's place of business.

The Department of Motor Vehicles' copy of the registration must be mailed to the South Carolina Department of Motor Vehicles, P.O. Box 1498, Blythewood, South Carolina 29016-0036 on the same day issued.
